

THE CORPORATION OF THE TOWNSHIP OF STRONG

BY – LAW #2009- 1596

BEING a By-law to provide for the Naming of Roads

WHEREAS the Municipal Act, 2001, S.O. 2001, Chapter 25, Part III Section 27 (1) authorizes that the Council of a Municipality may pass a by-law in respect of a highway only if it has jurisdiction over the highway;

AND WHEREAS the Council of the Corporation of the Township of Strong deems it expedient to name certain roads within the Township of Strong;

NOW THEREFORE Pursuant to the authority conferred to in Section 27 (1) Part III of the Municipal Act, 2001, S.O. 2001, the Council of the Municipal Corporation of the Township of Strong **Hereby Enacts as Follows:**

- (1) That the Description of Roads as indicated on the attached Schedule "A" Column 1 shall henceforth be known as Schedule "A" Column 2 – Road Name
- (2) That the Township of Strong Road Superintendant is hereby authorized to oversee the erection of the road name signs designating the road name.
- (3) That this by-law shall take effect and come into force on the date of its registration in the Land Registry Office in the District of Parry Sound.
