## THE CORPORATION OF THE TOWNSHIP OF STRONG BY-LAW #2014-018 As Amended

Being a By-law to prescribe a Tariff of Fees For LANDFILL #1 Located at Con 10 Pt. Lot 31 Township of Strong

WHEREAS Section 208.2 and 208.6(b) and Section 326 of the Municipal Act, 2001 provides that the Council of a municipality may by by-law prescribe a tariff of fees and collection process of these fees.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF STRONG DOES HEREBY ENACT AS FOLLOWS:

- 1. That Fee Schedule A for Land Fill #1 is for WASTE GENERATED within the boundaries of the Township of Strong, the Village of Sundridge and the Township of Joly **ONLY**.
- 2. The by-law shall be in full force on the date of final enactment and shall be posted in the Municipal Office foyer for Public Inspection.
- 3. Collection of the prescribed fee outlined above and as authorized under section 326 of the Municipal Act, 2001 may be recovered in a like manner as municipal taxes.
- 4. It is the policy of Council that (1) One Landfill Gate Card will be issued per household in the Township of Strong and Joly and the Village of Sundridge for those who apply for the card.
- **5.** It is the policy of Council that the Re-use Centre will be open on a year round basis.
- **6.** This by-law shall be in full force and effective on August 12, 2014 and By-law 2010-0024 is hereby repealed.

All regulations set out in By-law 2003-1463 shall also apply to any and all Landfill Sites under the control of the Township of Strong.
