Delegations: Barry Keown – Solar Farm Concern

Mr. Keown thanked council and his neighbours for the opportunity to speak on the Solar Farm project on Rodeo Road. Mr. Keown's presentation is attached to the Minutes. He reminded Council of the property in question being owned by Councillor Don Gore and thanked Mr. Gore for his service to the community. The land in question is quality farm land and has been farmed for several years. He is concerned with the traffic on Rodeo Road during construction, traffic issues that may arise, the quality of the road during construction, cost associated with maintaining the road, impact to wildlife in the area, hazards associated with solar farms, to his view now that he will be looking at a solar farm from his property. He was never approached by Saturn Power and feels that it was their responsibility to contact all property owners. He is requesting that Council vote no to the Solar farm application.

John MacLachlin – Agricultural Land concerns. Mr. MacLachlin although he is not abutting the solar farm he had several concerns with the loss of excellent agricultural land within the township. Mr. MacLachlin thanked council for the opportunity to discuss his concerns. He provided council with mapping information he had identifying this property as a class 4 –and this land is the best rating we have in the Township. This land is the same classification as the Magnetawan Silty Loam, Powassan Silty Loam and the Himsworth Silty Loam. He reminded Council of the quality of farm land in the Powassan area which is comparable to this property. He cautioned council that if the land is not maintained for the next 20 years it will not be good for farming. Agriculture programs are being implemented to encourage farms again in an effort to provide locally grown produce etc. These farms should be promoted and encouraged to create economic growth. Although he is not opposed to small solar projects he is opposed to large solar farms as they are not in our best interest. We have an abundance of hydro generation opportunities – biomass, water, methane etc, solar is not the best solution.
